AtCor Medical Holdings Limited (ASX:ACG) – Commitments Test Entity – Second Quarter Report

AtCor Medical today released its quarterly cash flow report for the period ending 31 December 2008.

Cash at quarter end was \$2,924,000, down \$402,000 from 30 September 2008. Net operating cash outflows of \$984,000 were recorded for the quarter, after cash collections of \$2,334,000.

The increase in second quarter outflows is offset by a significant increase in receivables in the quarter, attributable to strong growth in quarter to quarter sales. Receivables finished the quarter up over \$1.2 million compared to September 30.

During the period, two directors repaid outstanding loans and another director paid a portion from the outstanding balance. This provided \$459,000 in cash to the company. These loans were made prior to the company's initial public offering to exercise options over ordinary shares.

Operating cash outflows for the half-year to 31 December 2008 were \$1.159 million compared to \$2.376 million for the previous corresponding period, a reduction of 51%.

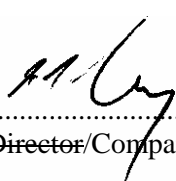
